



## **GILCON MATERIALS ROLL-OFF DUMPSTER SERVICE AGREEMENT AND GUIDELINES**

This is a guide to make your service and rental as efficient as possible. Please read the entire contents of this document.

**Loading:** The customer is responsible for the loading of the dumpster. The roll-off dumpster must be loaded evenly and level. NOTHING should be extended higher than the side or above the top rails. Trash, Construction Debris May Not be Loaded into Any of Our Dumpsters. We Only Accept Concrete Disposal in our dumpsters.

**Roll-Off Rates:** Rates charged for roll-off services includes delivery fees. GilCon Materials requires a flat and level surface for dumpster placement. The customer is responsible for any local city or municipality permit which may be required.

**Rental and Use of our equipment** serves as a contractual agreement for all roll-off dumpsters or containers, or any other hereby referred to as "equipment" rented by the Lessee from the Lessor commencing at the time the equipment is delivered and ending upon return to the Lessor' possession and or premises. Lessee Shall Not Sublet Equipment.

Customer agrees to indemnify and hold harmless GilCon Materials LLC, of any damage which may occur to the property where the equipment is placed. All responsible care shall be taken during placement and removal of the equipment to protect the property causing as minimal damage as possible. GilCon Materials LLC will not be held responsible for pavement markings, road surfaces, sod, lawn, asphalt, landscaping, overhead obstructions, or any other items or property that could or may become damaged.

Lessee is responsible for all damage to our equipment from the time the equipment is delivered until it is returned. This includes but is not limited to fire, theft, vandalism, negligence, graffiti, or any other activity which causes damage.

Customers acknowledge that during the dumpster rental, they will retain, care for, and control dumpster contents. Customer will indemnify and hold harmless GilCon Materials LLC, its owners, its employees, agents, and corporate associates of any damage or injury to persons or property while dumpster is in the customer's possession and until the contents are disposed.

GilCon Materials LLC accepts the following method of payment. Visa, MasterCard, Discover, American Express, PayPal, and Cash. Invoice can be paid in person or online. Payment is due Upon Delivery unless prior arrangements have been made.
